CASA MYRNA VAZQUEZ APPOINTS NEW MEMBERS TO BOARD OF DIRECTORS

Annie Lewis-O'Connor NP, PhD is a Pediatric and Ob-Gyn Nurse Practitioner and Sexual Assault Nurse Examiner whose career has been devoted to maternal and child health, specifically working with women and children who have been victims of intentional violence. She is currently at Brigham and Women's Hospital, where she is the Program Director of Nursing Practice in the Center for Women and Newborns.
